4. Categories of Personal Data

5. Legal Bases for Processing

The processing of your personal data is based on:

6. Recipients of the Data

Your personal data is processed by:

- IT service providers and systems acting as processors in accordance with Art. 28 GDPR

Your data will **not** be disclosed to other third parties.

7. Transfer to Third Countries

8. Storage Period

Data processed for the execution of the sweepstakes will be deleted after completion of the sweepstakes and after expiry of statutory retention periods.
